It has a 150mm wide weld bead on each side, marked with indication lines to ensure correct overlap.

OLDROYD® MultiSafe 1500 contains up to 10 % internally recycled material.

Product specification

OLDROYD® MultiSafe 1500 is based on OLDROYD Multi-Layer Technology™ and consists of three layers. It is white on the front towards the tunnel room and grey on the back. It has a black signal layer to disclose damagesand breakages.

OLDROYD® MultiSafe 1500 is suitable for hot air welding of all joints and comes on a roll in widths up to 4,2 m and lengths up to 60 m. Documentation is provided on request.

Cut-off criteria:

All major raw materials and all the essential energy is included. The production processes for raw materials and energy flows with very small amounts (less than 1%) are not included. These cut-off criteria do not apply for hazardous materials and substances.

Allocation:

The allocation is made in accordance with the provisions of EN 15804. Incoming energy and water and waste production in-house is allocated equally among all products through mass allocation. Effects of primary production of recycled materials is allocated to the main product in which the material was used. The recycling process and transportation of the material is allocated to this analysis.

Data quality:

Specific data for the product composition are provided by the manufacturer. They represent the production of the declared product and were collected for EPD development in the year of study. Background data is based on registered EPDs according to EN 15804, Ostfold Research databases, ecoinvent and other LCA databases. The data quality of the raw materials in A1 is presented in the table below.


